The Centre for the Study of Social Inclusion formerly known as the Centre for the Study of Social Exclusion and Inclusive Policy was sanctioned to Jamia Millia Islamia in the year 2008. This new Centre was attached with the existing Dr. K. R. Narayanan Centre for Dalit and Minorities Studies as 'Programme for the Study of Social Exclusion and Inclusive Policy' thus to strengthen and widen its focus to include the study of all forms of exclusion and discrimination. Drawing upon themes across disciplines and with a faculty having diverse expertise, the Centre employs an interdisciplinary approach to study marginalised strata of society. The Centre for the Study of Social Exclusion and Inclusive Policy became a separate entity on 22 March, 2016.

The Centre's primary objective is to generate knowledge on the socio-economic, political, and cultural issues pertaining to marginalized and socially excluded sections of the population. It aims to achieve this by encouraging interdisciplinary research and disseminating views and opinions concerning Dalit and Minority issues.
