Event Report of Celebration of National Pharmacovigilance Week (17th – 23rd September 2024) by Faculty of Dentistry, Jamia Millia Islamia.

National Pharmacovigilance Week ($17^{th} - 23^{rd}$ September 2024) with the theme of the "Building ADR Reporting Culture for Patient Safety, as a directive from DCI, was celebrated for the first time by Faculty of Dentistry (FOD), JMI. The essence of this programme was to impart awareness about the Pharmacovigilance Programme of India within JMI.

The Faculty members of Pharmacology organized and coordinated the 7 day programme in JMI. The main events covered were poster making competition on 17th September 2024 in which 26 teams registered for participation as group and 5 registered for solo participation.
