ADDENDUM

On the recommendation of the duly constituted Committee, the Vice-Chancellor, JMI in terms of Clause 11 (3) of JMI Act, 1988 and on behalf of the *Majlis-i-Talimi* (Academic Council)/*Majlis-i-Muntazimah* (Executive Council) has approved the inclusion of a new Para, Para (v) in the Clause 4(a) of the Ordinance - 9 (IX) Degree of Doctor of Philosophy (Ph.D.) [Academic] as given below:

4. Course Work

All scholars, except having M.Phil Degree,examination shall result in automatic cancellation of registration.

(a) The course work shall be of 16 credits, which may consist of the following:

- One Course of 4 credits computer applications.
- Two Courses of 4 credits each, of Post Graduate level.
- One Course of 2 credits on and publication misconduct.
- One Course of 2 credits his/her area of research.

(v) **In addition to above, specially designed courses of 2 or more credits of at least one semester duration offered by the Department / Faculty / Centre concerned in the relevant broad area of research.**

The action of the Vice-Chancellor will be reported to the Academic Council/Executive Council in its forthcoming meetings.
