NOTIFICATION

The *Majlis-i-Muntazimah* (Executive Council) in its meeting held on 30.12.2024 has approved the following amendment in **Clause 8 (a) of Ordinance 14(XIV) - 'Students Discipline' (Academic)** pertaining to composition of discipline committee:

"Without prejudice to section 30 of JMI Act 1988 as also Statute 31, there shall be a Discipline Committee comprising of the following members:

- (i) The Nominee of the Shaikhul Jamia (Vice-Chancellor) - (Chairman)
- (ii) The Naib Shaikhul Jamia (Pro - Vice-Chancellor)
- (iii) Registrar's Nominee
- (iv) The Dean Students' Welfare
- (v) The Provosts
- (vi) The Deans of the Faculties
- (vii) The Warden, who shall be invited, when the matter concerning his/her Hostel/Kitchen is required to be placed before the Committee for consideration; and
- (viii) The Chief Proctor (Member/Secretary)

In absence of the Nominee of the Vice Chancellor, Pro-Vice Chancellor will be the Chairman and in absence of both, the Nominee of the Vice-Chancellor and Pro-Vice Chancellor, the Registrar's Nominee will be the Chairman.

Provided that in any cases of sexual harassment of women/girl students, the Discipline Committee shall comprise of the following members:

- (i) Chairperson of the university Discipline Committee - Chairperson
- (ii) Two Nominees of the Vice-Chancellor who shall be women employed in the University
- (iii) Dean of concerned Faculty
- (iv) Head of the Department/Director of the Centre (as the case may be) of the Department/Centre to which the complaint belongs
- (v) Chief Proctor
- (vi) Dean, Students' Welfare

The Committee shall have the right to co-opt a woman who has experience of working for the cause of women."
