
### NOTIFICATION

The Officiating Vice-Chancellor, JMI on behalf of the Majlis-i-Talimi (Academic Council) and *Majlis-i-Muntazimah* (Executive Council) has approved the following amendment in the Para 2.7.4 (d) in the Ordinance - 15-E (Academic) pertaining to promotion policy in respect of the Bachelor of Physiotherapy (BPT) programme:

Existing provision	Amendment
2.7.4. Promotion  (d) A student will be promoted from the 3 <sup>rd</sup> year to 4 <sup>th</sup> year if he/she has cleared all the Practical Courses of the 1 <sup>st</sup> year and 2 <sup>nd</sup> year, 4/5 <sup>th</sup> of the Theory Courses of the 2 <sup>nd</sup> year, and two-third (2/3 <sup>rd</sup> ) of the total number of the Theory and Practical Courses combined of the 3 <sup>rd</sup> year.	2.7.4. Promotion  (d) A student will be promoted from the 3 <sup>rd</sup> year to 4 <sup>th</sup> year if he/she has cleared all the theory and practical exams of 1 <sup>st</sup> year; 4/5 of the theory courses and all the practical courses of the 2 <sup>nd</sup> year, and 2/3 of the total number of the theory and practical courses combined of the 3 <sup>rd</sup> year.

The above amendment will be effective from the Academic Session 2024-25.

The action of the Officiating Vice-Chancellor, JMI will be reported to the Academic Council and Executive Council in its respective forthcoming meetings.
