## Ordinance 14(XIV) – ‘Students Discipline’

### Part-I Ordinances and Regulations (Academics)

<u>EXISTING PROVISION IN ORDINANCE</u>	<u>REVISED ORDINANCE</u>
<p><b><u>Clause 8(a):</u></b></p> <p>Without prejudice to section 30 of JMI Act 1988 as also Statute 31, there shall be a Discipline Committee comprising of the following members</p> <ul style="list-style-type: none"><li>(i) The Shaikhul Jamia (Vice-Chancellor) – (Chairman);</li><li>(ii) The Naib Shaikhul Jamia (Pro – Vice-Chancellor);</li><li>(iii) The Dean Students’ Welfare;</li><li>(iv) The Provosts;</li><li>(v) The Deans of the Faculties;</li><li>(vi) The Warden, who shall be invited, when the matter concerning his/her Hostel/Kitchen is required to be placed before the Committee for consideration; and</li><li>(vii) The Chief Proctor (Member/Secretary)</li></ul> <p>Provided that in any cases of sexual harassment of women/girls students, the Discipline Committee shall comprise of the following members:</p> <ul style="list-style-type: none"><li>(i) Chairperson of the university Discipline Committee – Chairperson</li><li>(ii) Two nominees of the Vice-Chancellor who shall be women employed in the University;</li><li>(iii) Dean of concerned faculty;</li><li>(iv) Head of Department/Director of the Centre (as the case may be) of the Department/Centre to which the complaint belongs;</li><li>(v) Chief Proctor;</li><li>(vi) Dean, Students’ Welfare</li></ul> <p>The Committee shall have the right to co-opt a woman who has experience of working for the cause of women.</p>	<p><b><u>Clause 8(a):</u></b></p> <p>Without prejudice to section 30 of JMI Act 1988 as also Statute 31, there shall be a Discipline Committee comprising of the following members:</p> <ul style="list-style-type: none"><li>1. Pro Vice-Chancellor (Chairman) (In absence of the Pro-Vice Chancellor, senior most Dean among the members of the Executive Council in the category of Deans of the Faculties will chair the meeting of Discipline Committee);</li><li>2. One Dean of the Faculty nominated by the Vice-Chancellor for a period of one year or till tenure as Dean whichever is earlier;</li><li>3. One Director of the Centre nominated by the Vice-Chancellor for a period of one year or till tenure as Director whichever is earlier;</li><li>4. One Principal of a College/School nominated by the Vice-Chancellor for a period of one year or till tenure as Principal whichever is earlier;</li><li>5. Registrar; or his nominee</li><li>6. One female Professor of the University for a period of one year;</li><li>7. Chief Proctor (Convener/Secretary).</li></ul>
