3(vi)		<p>Add the following new sub-para no. (vi) following sub-para no. (v): If a faculty member, at the verge of his/her superannuations, is awarded a distinguished fellowship to carry out research work after his/her superannuations, he/she may be permitted to register students for Ph. D. Programme from the date of availing such fellowship, provided that:</p> <p>(a) The duration of the fellowship is not less than three years,</p> <p>(b) The faculty member submits an undertaking to the University stating that he/she will serve the University during the entire period of the fellowship.</p>
