(40.01) CONFIRMATION OF THE MINUTES OF THE 39th
MEETING OF THE MAJLIS-i-MALIYAT (FINANCE

The Finance Committee confirmed the Minutes of the 39th Meeting of the Majlis-i-Maliyat (Finance Committee) held on 26th June, 2018.

However on Item No.39.04 the Committee directed that the Ministry may be informed that, as directed by UGC in its letter dated 13.02.2018, for relocation of JJ Basti the payment of Rs 80.42 Lakh has been made to Delhi Urban Shelter Improvement Board (DUSIB) from University's internal resources.

The representative of JS & FA further highlighted that as a policy the land has to be provided free of cost by the State Government.

Therefore, DS (Finance), DHE, insisted that a detailed proposal in this regard may be forwarded to MHRD for consideration, with valid justification.

(40.05) APPROVAL OF THE REVISED BUDGET ESTIMATES FOR THE FINANCIAL YEAR 2018-2019 AND THE BUDGET ESTIMATES FOR THE YEAR 2019-2020.

The Revised Budget Estimates for 2018-2019 and the Budget Estimates for 2019-2020 were placed before the Finance Committee. After detailed deliberation, the Finance Committee approved the following expenditure/ceiling of grant subject to the availability of funds.

The representative of JS & FA, Ministry of HRD, stated that, as already instructed by MHRD and UGC all major infrastructural projects, including construction of buildings and campus development etc in Central Universities from the year 2018-19 onwards will be through project based funding and through Higher Education Funding Authority (HEFA). Therefore under Creation of Capital Assets [OH-35] fund requirement for minor civil works, books and journals and equipment etc can only be projected to UGC for RE 2018-2019 and BE 2019-2020, based on realistic assessment of the requirement of JMI.

The comments received from MHRD on the agenda item No. 40.08 for the F.C. (19/11/2018) were deliberated.

Regarding Item Nos. 1, 2 & 3 the UGC has already sanctioned Rs 25.00 crores, Rs.25.00 crores and Rs.8.00 crores respectively (Total Rs.58.00 crores for Boys, Girls Hostel and Foreign Students Hostel). Out of Rs.58.00 crores, UGC has released Rs.10.00 Cr each for Boys and Girls

Hostel and Rs.8.00 Crores for Foreign Students Hostel (Total Rs.28.00 crores) with the condition to start the project after seeking approval from Building Committee, Finance Committee, Executive Council and Standing Committee of UGC. The recommendations of the Building Committee held on 05.11.2018 are placed before the Finance Committee.

Thereafter, it is to be approved by E.C. and Standing Committee of UGC. The construction of the projects will be taken after approval from Standing committee of UGC and their assurance to provide balance amount of Rs.15.00 Cr each i.e. Rs 30.00 Cr to complete these projects.

Regarding Items at S.No. 10, 11 & 12 funds have been sanctioned and are already available with the University. Various works under Campus Development and other infrastructure have been awarded and are in progress.

Regarding Item No 9, it is small addition and alteration work under DRS-II Scheme funded by UGC.

The Representative of JS & FA, MHRD, reiterated the instructions of MHRD regarding project based funding through HEFA for all infrastructure projects of Central Universities and advised the University to seek clarifications from UGC/MHRD, if required, in this regard.

Finance Committee approved the above recommendations of the Building Committee.

The meeting ended at 1:00 p.m. with a vote of thanks to the Chair.
