THIS MEMORANDUM OF UNDERSTANDING IS SIGNED, AGREED AND CONSENTED ON _______ DAY OF ________, 2006.

BETWEEN

CENTRE FOR DEVELOPMENT OF ADVANCE COMPUTING, C-56/1, Anusandhan Bhawan, Institutional Area, Sector-62, Noida – 201 307, Uttar Pradesh, INDIA (hereinafter referred to as CDAC, Noida), a Scientific Society under the Department of Information Technology, Ministry of Communications and Information Technology, Sovernment of India, acting through its authorized signatory & Director (Sp. App.), Sh. V.N. Shukla

AND

FAMIA MILLIA ISLAMIA (hereinafter referred to as JMI), a Central University with a perpetual succession and a common seal, created by an enactment of the Parliament of India, i.e., the Jamia Millia Islamia Act, 1988, acting through its authorisd signatory and Registrar, Sh. S.M. Afzal.

BACKGROUND

CDAC, Noida is executing a project entitled Digital Library Mega Centre sponsored by Ministry of Communications and Information Technology, Government of India. The project has been started in April, 2004 and digitization of books is targeted for completion within the stipulated period of two years.

Jamia Millia Islamia has a Central Library (i.e., the Dr. Zakir Husain Library) and a number of Faculty and Centre Libraries. The Dr. Zakir Husain Library has a collection of about 3.28 Lacs books & bound volumes and subscribes to 379 journals.

The said Library has 2500 manuscripts in Arabic, Persian & Urdu. These pertain to 15th - 18th century; and related to Culture, History, Literature, Islamic Studies, Philosophy, Geography Astrology, etc. There are about 1000 rare books in English, Arabic, Persian & Urdu pertaining to various subjects. The library also has some valuable books in Urdu language on Veda, Upanishads, Ramayan, Mahabharat, Bhagavat Gita, Bhagwan Mahavir, Gautam Budh, Guru Nanak and Sikh religion, Swami Dayanand Saraswati, Swami Vivekanand, Sri Aurobindo, Radha Swami Movement, etc. The Library has valuable source material on the history of freedom movement in the form of private papers of the eminent leaders such as Maulana Mohd. Ali Jauhar, Hakim Ajmal Khan & others. The Library has a separate "Jamia Authors Collection" of 3000 books written, edited and compiled by persons who are or were associated with Jamia

The Dr. Zakir Husain Library's Digital Resource Centre provides electronic access to 14,000 E-journals through 26 major databases in various areas of Sciences, Social Sciences, Religious Studies, Arts & Humanities, Engineering & Law. The Library has fully computerized its English and Hindi collection, which is now available to users through Online Catalogue. It includes a centralized database of all the theses awarded by the Jamia. The Library has a dedicated Internet Area where students are encouraged to make use of E-Journals, with regular Orientation Programme.

The Library has also been functioning as a referral centre on Islamic Studies, Urdu language & literature and receives requests for its bibliographic information from all over the country. A number of scholars visit the Library from the country & abroad for its reference & consultation.

With a rich collection and Library's well-developed Digital Resource Centre, the Dr. Zakir Husain Library has been recognized as one of the sources of such multilingual data which will be useful for Digital Library creation. The Jamia Millia Islamia agrees to participate in the project and contribute manuscripts, rare books, periodicals, etc. for the Digital Library Mega Centre.

Use

The ultimate aim of the project is to digitize identified rare books, manuscripts & newspapers and make use of the multi-lingual contents for research purposes in OCR test-bed and create other digital Library tools. Only those books and resources which are free from copyright will be uploaded on the web.

> the rare books, manuscripts, serials, etc. which are useful for this project will be identified by experts of Dr. Zakir Husain Library and the CDAC, Noida. Dr. Zakir Husain Library will provide single copy of such a document free of charge and necessary support.

CDAC, Noida will digitize the rare books, manuscripts, serials or other documents provided by Dr. Zakir Husain Library.

- III. CDAC, Noida will digitize the documents and a copy of the same in CD format will be provided to Dr. Zakir Husain Library free of charge for archival purpose. Dr. Zakir Husain Library is free to use the CD for any purpose. However, due recognition for the work done by CDAC, Noida shall be acknowledged in CD and in its further usages.
- IV. CDAC, Noida will not use the content provided by Dr. Zakir Husain Library for any commercial purpose, whatsoever. CDAC, Noida shall give due recognition for the content provided by Dr. Zakir Husain Library in project and related technical papers. The digitized data free from copyright will be uploaded on the web.
- CDAC, Noida may use the content provided by the Dr. Zakir Husain Library for research purposes and share it with like minded research organizations under intimation to them.
- VI. CDAC, Noida shall not have any rights to change the content of any book/periodical of any document provided by the Dr. Zakir Husain Library. All rights of publication of the content published by Dr. Zakir Husain Library will remain with them.
- VII. The University Librarian will be the Director of all the Digitisation Initiatives on behalf of the Dr. Zakir Husain Library, JMI.

Other Terms and Conditions

This agreement shall be valid for a period of FIVE years from the date of signing, even if the Digital Library Mega Centre project is completed earlier.

Arbitration

In the event of disputes or differences between the parties mentioned hereto, such disputes or differences shall be resolved amicably by mutual consultation and in case of NON-resolving of issues then through arbitration.
