THIS MEMORANDUM OF UNDERSTANDING IS SIGNED BETWEEN:

Jamia Millia Islamia, a Central University created by an enactment the Parliament of India (i.e. the Jamia Millia Islamia Act, 1988) and is a body corporate with perpetual succession and a common seal (acting through its Registar Mr. S. M. Afzal.)

And

the Centre for North East Studies and Policy Research [C-NES which is registered as a Trust, under Sec.80G/ Income Tax Act 1961 as well as Foreign Contributions Regulation Act (FCRA), set up in 2000 by eminent citizens to study, analyse, research and work on issues relevant to the Northeastern region (acting through its Managing Trustee Mr. Sanjoy Hazarika (C-NES, D/6, 6143/3, Vasant Kunj, New Delhi 110070. India. Tel: 91-11-26121426 and C-NES, ILASHREE, House no 9, 2rd Bye Lane, Rajgarh Road, Guwahati-781003, Assam, India. Tel: 91-361-2454376, 2528652. http://www.c-nes.org.).]

AND WHEREAS it is the statutory object of the Jamia Millia Islamia to disseminate and advance knowledge by providing instruction, research and extension facilities in such branches of learning as it may deem fit and it shall endeavor to provide to students and teachers the necessary atmosphere and facilities for the promotion of:

- innovation in education leading to structuring of courses, new methods of teaching and learning and integral development of personality,
- II. Studies in various disciplines,
- III. Inter disciplinary studies, and
- IV. National integration, secularism and international understanding

NOW THEREFORE, the Jamia Millia Islamia and the Centre for North East Studies and Policy Research have intended, agreed and consented to the following terms and deeds in pursuance of a common intent to promote and develop the studies of North East India.

Saying Hazarka

1. FIELD OF COOPERATION

- Both parties shall evolve a mutually acceptable schedule to develop programmes, hold seminars and exchange visit.
- b) The said academic interaction and intellectual assimilation may includes:
 - i. Faculty, staff development and exchange;
 - ii. Exchange of students, seminar research, conferences and workshop;
 - Collaboration in the sharing of academic data, scientific information, intellectual property, articles and publication;
 - iv. Advice surgeries, placements and executive training; and
 - v. Establishing a centre in pursuance of the intent to study, analyse, research and work in relation to the North Eastern Region of India in accordance with the Act. Statutes and Ordinances of JMI.

2. STUDENT /TEACHER COLLABORATION:

- a) Reciprocal arrangements based on a mutually acceptable terms shall be developed to give an impetus to collaborative research and joint projects. Teachers, researchers, guides and students of both the parties and their collaborating agencies shall be encouraged to work in tandem in the laboratories, workshop, faculties and department of both the institutions.
- Issues relating to travel, boarding, lodging, miscellaneous expenses shall be according to the rules, regulations and policies of Jamia Millia Islamia.

3. MISCELLANOUS:

a) The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.

- b) The parties to this memorandum may, by mutual consent, add modify, amend, delete review, or revise any term (s) and condition (s) of this agreement.
- c) This Memorandum of Understanding shall remain in force for a period of five years from the date of its signature and seal and may be terminated by either side by giving a six months notice to the effect in writing. However, not withstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties flowing and subsisting therein shall be respected and mandate till the finalization and accomplishment there for.
- The parties to the Memorandum of Understanding undertake to treat as "confidential and privileged" information of the other institutions which is so classified in advance. The terms of confidentiality and mode of discloser shall be as per mutually acceptable terms.
- e) This Memorandum of Understanding shall require the ratification of the competent academic/executive body of both the institutions.
