



- b) To facilitate theoretical and action-oriented research programmes in the field of mass communication with special emphasis on Indian society, both rural and urban.
 - c) To facilitate exchange of scholars - both at the faculty and student level-between these two educational organisations on short-term, reciprocal basis.
 - d) To jointly organise seminars, workshops, conferences, fieldwork and other such academic activities to heighten the standards of mass media education in the country.
 - e) To develop academic courses jointly so as to further the causes of both the academic communities.
 - f) To develop packages for both formative, summative and evaluative research projects in mass media of communication at global, national and regional levels.
4. Whereas Kuvempu University has started a Post Graduate programme of Mass Communication and Journalism the said Department in Jamia Millia Islamia is highly developed and prestigious one. Therefore, Kuvempu University desire that the students admitted to MA (Mass Communication and Journalism) in Kuvempu University should get the benefit of spending at least one semester in Department of Journalism in Jamia Millia Islamia, so that they get advanced training in the field of study. - i) No. of faculty from each institution.
 - ii) The duration of the deputation.
 - iii) TA/DA shall be borne by the respective institutions.
 - iv) Free accommodation shall be provided by receiving institution.
8. **SEMINAR, WORKSHOP, CONFERENCE, ETC.:** Both the institutions shall organise Seminar, Workshop, Conference, etc. alternatively on mutually agreed dates. The details of workshop shall be worked out by the host institution in consultation with other institution.
9. **APPLICATION OF REGULATION:** The students sponsored by the respective institutions shall be governed by the regulations of the respective institutions regarding admission, examination, award of degrees, etc. The degree shall be awarded by admitting University but a certificate may be issued jointly by both the Universities for students who have received coaching in both the Universities.
10. The chairman of departments of both the Universities shall discuss and finalise modalities, in consultation with respective Vice-Chancellor/Registrar.
11. **BUDGET:** Both the Chairpersons/Directors of the concerned Departments of Mass Communication, in consultation with the respective University authorities shall prepare the Annual Budget Estimate every year.
12. **PAYMENT OF TA, DA AND HONORARIUM:** The resource persons, invitees, guests, and other persons invited for the Department shall be paid honorarium, TA, DA, and other allowances, in accordance with the rules of respective Universities.
