



While endorsing the above decision, the observation made by Prof. Shyamala A. Narayan, Head, D/o English regarding shifting of one Professor from English to Centre for Physiotherapy & Rehabilitation Sciences were noted for consideration.

### **3.11 Addition of Specialization**



However, on clearing the Supplementary Exams they shall pay entire fee for 2<sup>nd</sup> year BDS Course, however if they fail they shall pay fee for the 1<sup>st</sup> year BDS Course as per JMI rules as they will be attending 1<sup>st</sup> year classes regularly”*

The Majlis (EC) considered and approved the proposal for conferring the *Honoris Causa* on the following distinguished dignitaries on the occasion of Annual Convocation 2011/Special Convocation as approved by the Academic Council in its meeting held on 15.12.2010 vide Resolution No. 14:

1. **Dr. Desmond Mpilo Tutu**, South African activist and Christian cleric who rose to worldwide fame during the 1980s as an opponent of apartheid.
2. **Mr. Muhammad Yunus**, Bangladeshi economist and founder of the Grameen Bank.
3. **Sheikh Khalifa bin Zayed bin Sultan Al Nahyan** the President of the United Arab Emirates (UAE).

4. **Prof. Amartya Sen**, an Indian economist who was awarded the 1998 Nobel Prize in Economic Sciences for his contributions to welfare economics and social choice theory.

The Majlis (EC) considered and approved the proposal to request the University Grants Commission to convert one position of Asstt. Professor to Dy. Director in the Pay Band of Associate Professor or sanction an additional post of Dy. Director in the Pay Band of Associate Professor for the Residential Coaching Academy, Jamia Millia Islamia.

1. A second class Master's degree in any stream with at least 55% marks from a recognized University.
2. At least eight years of experience of coaching aspirants for Union Civil Services/Provincial Civil Services/other services conducted by public and private sector undertakings in any reputed institution/university

**Desirable:**

1. Preference will be given to those who have experience of coordinating classes, conducting test series and administrating a coaching institute.
2. Proficiency in English, Hindi and Urdu.

The Majlis (EC) approved the proposal in principle but advised to get it examined by the Audit before proceeding further.



The Majlis (EC) was informed that Jamia Millia Islamia has been trying to get the Pahari lands "Khasra No. 67/2, 68/3, 68/4" for many decades. Despite enormous effort it had not been possible to get the lands acquired. However, now the Lt. Governor of Delhi has been pleased to issue Notification (No. F.9[82]/2003/L&B/LA/14621 dated 8.2.2011) under Section 4(1) of the Land Acquisition Act, 1894 for acquisition of these lands as specified below:

It was informed that the notified beneficiary of the land shall be Jamia Millia Islamia and the University will be required to pay and deposit the charges with the concerned civic/ acquisition authorities (as and when a demand is made) for securing possession/ title over the said lands. The amount will be in the proximity of Rs.30 crores.

It is inevitable that in such complex cases various issues are likely to come up or be raised by different individuals/ groups who have interest in the said lands. The acquisition may be simple, but the possibilities of litigations by the U.P. Government or other interested parties can not be ruled out. The Majlis (EC) must be aware that this could require making serious financial and administrative decisions by the Vice-Chancellor at short notice. The Majlis (EC) will be kept informed of such decisions.


The Statute 14 (vi), (vii) and (viii) of the Jamia Millia Islamia Act empowers the Majlis-i-Muntazimah (E.C.) to inter alia manage/ regulate finances/properties of the University, invest monies in purchase of immovable properties and to accept transfers of such properties.

The Majlis (EC) considered and authorized the Vice-Chancellor to approve the payment(s) as demanded (from time to time), as also accept transfer(s) of the notified lands or to handle any matter related to the issue in view of the above and enable the Jamia to process the said acquisition smoothly without any hindrance.

**[Action: Property Incharge /AR, Property]**

While approving the above proposal, all the members of the Executive Council formally appreciated the sincere efforts made by Mr. Najeeb Jung, Vice-Chancellor for getting acquisition of *Pahari* land of 214 *Bighas* and 19 *Biswas* (Khasra No. 67/2, 68/3 & 68/4) to Jamia. The Vice-Chancellor appreciated the efforts of Mr. N. U. Siddiqui, Consultant (Property).

Thereafter, the meeting was concluded at 4.10 p.m. with a vote of thanks to the Chair.
