DECISION

The Minutes of the meeting of the Executive Council held on 22.02.2023 were placed before the House for confirmation. The matter was discussed at great length and it was resolved that the UGC guidelines on CUET will be adopted through the concurrence of the Academic Council and the Executive Council of the University. The House resolved that a legal advice be sought on this matter from the Legal Advisor of the University, before placing it in the Academic Council. During the discussion, it was explained by Prof. Eqbal Hussain, who was also the designated Estate Officer of the University, appointed by the Ministry of Education, that it would not be in the interest of the University to purchase the said land, as another land purchased 21 years ago by the University from the same owner, has not been used by the University till now and it would not be desirable to purchase another small piece of land, surrounded by habitation.

The Chairperson of the House asked the Finance Officer, who was present as a Special Invitee, in his capacity as a Finance Officer of the University and as per Statute 6(5) (i) of the JMI Statutes, responsible to hold and manage the property of the University, to express his views in the matter. In response, to the query raised by the Chairperson, the Finance Officer strongly emphasized that it would not be in the interest of the University to purchase a small piece of land, as the University has financial responsibility to pay back to HEFA and also huge funds will be required for upcoming development projects of full scale medical college and a hospital as well as other academic expansions, therefore, it would be detrimental in the interest of the University to invest in purchasing such unplanned piece of land.

Other members of the Executive Council, Prof. Ibraheem (DSW), Mr. Rajesh Bhagwat Jadhao (Senior Most Assistant Professor) and Prof. Mamoon Nomani (Senior Dean), strongly supported the stand taken by Prof. Eqbal Hussain and the Finance Officer in the interest of the University.

After due deliberations on the issue, the following members agreed with the proposal that JMI should not purchase the said land and shall grant NOC in respect of the said land:

1. Prof. Ibraheem, DSW
2. Prof. Eqbal Hussain, Dean, Faculty of Law
3. Prof. Mamoon Nomani, Dean, Faculty of Fine Arts
4. Mr. Rajesh Bhagwat Jadhao, Senior Most Assistant Professor, Department of Applied Sciences & Humanities

However, the following members of the Executive Council were not in agreement to grant the NOC in respect of the said land:

Therefore, 5 members including the Chairperson gave their assent for grant of NOC and 3 members gave their dissent.

After the EC meeting ended, 4 members of the EC sent their reasons in writing for giving assent to grant NOC and 3 members sent their dissent. As noted above, one member Dr. Hemalatha R. was not present during the discussion on the said agenda item.
