## MINUTES

An Ordinary meeting of the *Majlis-i-Muntazimah* (Executive Council) [EC-II(ORD-I)/2024] was held on 31.07.2024 at 11:00 a.m. in the Yasser Arafat Hall, Administrative Block, JMI.

Prof. Sanjay Srivastava sent an email that he is preoccupied and cannot attend the meeting of the EC. Dr. Hemlatha R. sent an email stating to the effect that she is not keeping well, and therefore, unable to attend the meeting. The Secretary of the Executive Council informed the members present that the Offg. Vice-Chancellor can convene the meeting of the Executive Council in terms of the letter of the Ministry dated 09.10.2014 bearing F.No. 19-58/2014 Desk(U), Government of India, Ministry of Human Resource Development, Department of

Higher Education as quorum of minimum 05 (five) members is complete in terms of Statute 13(2) of JMI Act, 1988.

At the outset, the Registrar requested the Vice-Chancellor to call the meeting to order. The Vice-Chancellor called the meeting to order.

Thereafter, the Registrar, JMI sought permission from the Vice-Chancellor to take up the following Agenda items.

**Item – 01**

**CONFIRMATION OF THE MINUTES OF THE ORDINARY MEETING OF THE EXECUTIVE COUNCIL HELD ON 04.08.2023 AND SPECIAL MEETINGS OF EXECUTIVE COUNCIL HELD ON 05.12.2023 AND 24.05.2024**

**DECISION**

The EC has unanimously resolved to approve and confirm the minutes of ordinary meeting of EC held on 04.08.2023 which was circulated on 07.08.2023 except Item No.10. Item No. 10 is reproduced herein below which is unanimously not approved:-

**“*Item No. 10* - To consider No Objection Certificate sought by Mrs. Zakia Zaheer, w/o Shri Syed Kazim Zaheer in order to dispose of her land.”**

The EC has also approved and confirmed the Minutes of Special Meeting of the EC held on 05.12.2023 and 24.05.2024 respectively.

**Item – 02**

**ACTIONS TAKEN REPORT ON THE MINUTES OF THE EXECUTIVE COUNCIL (EC-II/2023) HELD ON 04.08.2023**

**DECISION**

1. The Majlis (EC) approves the report of actions taken on the minutes of the ordinary meeting of the *Majlis-i-Muntazimah* (Executive Council) held on 04.08.2023 and Special Meetings of the Executive Council held on 05.12.2023 and 24.05.2024.
2. As regards Item No. 9 regarding termination of lease deeds, it was resolved that the University shall take steps as advised by the Standing Counsel of the University to issue fresh notices under the transfer of Property Act.
3. The Executive Council has discussed the matter in detail, in respect of Item No.10 relating to issuance of purported No Objection Certificate dated

04.08.2023. The House has deliberated on this issue in terms of the Hon'ble High Court in WP(C) No.12598/2023 passed in Haris-ul-Haq V/s JMI, whereby it was directed that the Minutes of the Meeting dated 04.08.2023 should be placed before the Executive Council for its consideration/approval in terms of regulations of the EC. The House has, also, taken note of the Affidavit filed by Prof. Nazim Husain Jafri in the above-captioned matter. The House perused all the material on record as well as discussed Resolution No.10 dated 04.08.2023 of the EC and its contents wherein it had nowhere specifically resolved to grant any permission or authorization to the then Estate Officer to issue such No Objection Certificate (NOC). Copy of the said NOC was placed before the House as Annexures to the Agenda. The letter has been perused and reproduced herein and it is clearly seen that the Estate Officer had issued a NOC to Ms. Zakia Zaheer with the following observations:



This is in reference to your request Jamia Millia Islamia, New Delhi, to provide: 'No Objection Certificate' regarding property admeasuring 855.50 sq. yards, bearing Municipal No. 267-A, Khasra No. 493/143 and 496/143 Village Okhla, New Delhi-110025 referred in your family settlement deed and as per the condition of the Exchange Deed executed on 17.12.1957.

The matter was placed before the Executive Council at its meeting held on 04.08.2023 for taking a decision in this regard, and the Council has resolved that it would not be in the larger interest of the University to purchase the said land, at this stage, hence, the Executive Council decided to issue a 'No Objection Certificate' to you, as requested by you. Thus, your request has been acceded to by the University.

- 3.1 The Estate Officer did not send the copy of said letter to any of the Sections as mentioned and also, there was no permission and authorization to the Estate Officer to issue such communication under the letter head of office of the Estate Officer. The EC has taken serious note of the contents of the letter, where the Estate Officer, has conveyed a decision on behalf of the EC, whereas, on perusal of the said Resolution of the EC dated 04.08.2023, no such decision or resolution, in respect of any request having been acceded to by the EC in clear and ambiguous terms. The Secretary is unable to show any file/document on record, where or how such authorisation was given to the Estate Officer to issue the said letter dated 21.08.2023.
- 3.2 The Hon'ble members of the EC posed a query to the AR (Council), who was present in the meeting to inform that whether any such file has been routed through the Council Section for giving any approval for grant of NOC and also communicating any such decision of the EC to Ms. Zakia Zaheer. The reply was in negative.
- 3.3 The Secretary informed the House that neither of the sections nor even his office is in possession or in receipt of such purported letter dated 21.08.2023.
- 3.4 It was also discussed and deliberated that the Estate Officer was not within his powers even by way of any authority or by the statute or even under delegation of power of the Vice-Chancellor to issue such communication on behalf of the Executive Council to Ms. Zakia Zaheer. Therefore, at the first instance, the House hereby unanimously sets aside the said letter dated 21.08.2023. The House has taken serious cognizance for such misuse of powers by circumventing procedure with malaice and lapses as well in subordination. The EC, in view of the facts and circumstances, has unanimously resolved that a High Level Inquiry Committee be constituted in the matter as to under what circumstances this letter was issued by the Estate Officer without process/approval or authorization.
- 3.5 Therefore, the matter has been carefully considered and the House has also resolved to appoint a 03 (three) members High Powered Committee preferable headed by a retired Judge of Hon'ble High Court. The House, unanimously, resolves to authorize the Vice-Chancellor to constitute a Committee for the said purpose. The records qua the land in question are also directed to be seized by the Registrar, forthwith, including all documents inter-alia relating to the said land and the Minutes of EC dated 04.08.2023 immediately. The House hereby resolved that the High Level Committee will submit its report in a sealed cover within a period of 06(six) weeks from the date of notification of the Inquiry Committee.
- 3.6 It has also been resolved by every member present in the House that considering the seriousness of the facts/matter, it is appropriate and expedient, in the best interest of the University to suspend Prof. Eqbal Hussain, Faculty of Law and Estate Officer, forthwith untill the Inquiry is completed to ensure that there is no tampering of record or that any such record is not created to



circumvent the sanctity of the Inquiry Committee which is being constituted for the said purpose. The Vice-Chancellor is authorized to take all necessary steps in this connection, in accordance with rules/regulations and the action taken shall be reported in the next meeting of the Executive Council.

- 3.7 In view of the above and considering the nature of allegations, prima-facie, found against the present Estate Officer, the EC deems it appropriate to resolve to request the Ministry of Education through the Vice-Chancellor to appoint a new Estate Officer, so that the office of the Estate Officer is not affected.

**DECISION**

At this stage, the Secretary of the Executive Council, Mr. M. Nasim Haider left the meeting and Mr. Jitender Singh, Deputy Registrar/Offg. Controller of Examinations was requested by the Chair to become the Secretary and apprise the House of the deletion of Agenda Item mentioned at 3.27, which has been inadvertently mentioned.

At the outset, it was brought to the notice of the House that point no. 3.27 regarding appointment of Mr M. Nasim Haider, Deputy Registrar-I as Officiating Registrar' has been brought to the agenda of this meeting inadvertently as this has already been confirmed by the Executive Council at its meeting held on 24.5.2024, therefore, it may be considered as deleted from the current agenda. Accordingly, the House approved the point no.3.27 as deleted.

Thereafter the House noted and approved the following actions taken by the Vice-Chancellor, JMI, on behalf of the Executive Council in terms of Section 11(3) of JMI Act, 1988. 

**DECISION**

The House has deliberated on the matter in great detail and has also carefully perused the documents on record as well as the recommendations of the Inquiry Committee dated 03.11.2023, wherein the charges have been proved. The House has also carefully perused the meeting of the Minutes of Meeting of the Board of Management convened on 08.11.2023 which had recommended that major punishment be imposed upon him considering his past conduct. A Committee, thereafter, was constituted under the Chairmanship of Prof. Seemi Farhat Basir and has submitted a report dated 29.07.2024. The recommendations of the Committee were discussed and the House has unanimously resolved to impose major punishment i.e. withholding of two increments of pay on Mr. Haris-ul-Haq. The Committee has also recommended that his suspension may be revoked. The House has unanimously accepted the recommendations and approved the punishment, so recommended as well as to revoke his suspension. The House has also resolved that Mr. Haris-ul-Haq should be vigilant, careful and maintain good conduct.

Vice-Chancellor. The House expressed great concern as to how a public premises was allotted by the then Offg. Vice-Chancellor, who was holding dual charges of Offg. Vice-Chancellor and as an Estate Officer. The House has unanimously resolved to cancel the allotment of Quarter No.B-112, situated at Khan Abdul Ghaffar Khan Enclave to Dr. Asif Umar, forthwith, and directs him to vacate the said premises within a period of ten (10) days by handing over the possession of the said quarter in its original position to the Property & Estate Section. The quarter is relegated back to the pool which may be allotted to the person/staff eligible based on the recommendations of the allotment committee.



irregularities, gross misconduct and violation of the University guidelines as well as service rules. The House authorized the Vice-Chancellor to constitute a High Level Inquiry Committee of three members for the purpose of initiating departmental action for major penalty against Prof. Khalid Moin as recommended by the CBI.

**DECISION**

The House has carefully discussed the Office Order dated 26.03.2024 issued by the University on the approval of the then Offg. Vice-Chancellor of reducing the period of probation and confirming the services of Mr. Mohd. Hadis Lari in contravention of the rules and regulations and in addition to contempt of the order dated 20.10.2023 passed by the Hon'ble High Court of Delhi in Dr. Arshad Hussain Vs JMI. It was reported by the Finance Officer and the Secretary of the EC that the original file is missing from the records and a carbon file has been created. The recommendations of the Committee of the Selection Committee dated 06.09.2023 recommended and appointed Mr. Mohd. Hadis Lari as Deputy Registrar on probation for a period of one year. The House took serious note of the fact that the rules, procedure, regulations and the ordinances of the University were circumvented, and the probation period was reduced and the services were confirmed without assigning any special reason as well as in contempt of the Order of the Hon'ble High Court. The House has seriously taken strong note in the manner and the procedure followed for such action. Therefore, the House unanimously resolved that the Office Order dated 26.03.2024 is set aside void ab-initio and consequently, it is resolved that Mr. Mohd. Hadis Lari shall complete one year of probation deducting the period spent by him as confirmed.

**Item – 16**

**TO CONSIDER THE APPEAL OF PROF. NUZHAT PARVEEN KHAN, FACULTY OF LAW, JMI, UNDER SECTION 31 OF THE JMI ACT, SEEKING TO SET ASIDE THE OFFICE MEMO DATED 07.09.2022**

**DECISION**

The House carefully perused the ground of appeal filed by Prof. Nuzhat Parveen Khan under Section 31 of the JMI Act to set aside the Office Memo dated 07.09.2023. The House also carefully perused the record of the Inquiry Committee as well as the recommendations in the light of the grounds taken by Prof. Nuzhat Parveen Khan in her appeal. The House, after perusal of the record, was of the unanimous opinion that there were certain lapses and violation of principle of natural justice and therefore resolved to partially set aside the recommendations of the Committee i.e. (i) Penalty of withholding of one increment with cumulative effect be imposed on Prof. Nuzhat Parveen Khan (ii) No administrative responsibility in Jamia may be given to Prof. Nuzhat Parveen Khan. The House further resolved that the third recommendation i.e. to recover an amount equivalent of missing items from Prof. Nuzhat Parveen Khan made by the Inquiry Committee be sustained in view of the fact that the equivalent amount stands recovered from her. Therefore, to the above extent the appeal partly stands allowed.

**DECISION**

The Secretary and the Chief Legal Advisor explained the facts of the case of Mr. Mohd. Javed Malik V/s JMI in respect of the appointment of Prof. Nazim Husain Jafri as a Professor. The House deliberated and perused the record of the affidavit filed by Deputy Registrar-II on the direction of the Offg. Vice-Chancellor. The House has also perused the affidavit filed by the University in July, 2024 to explain the House in which the said affidavit was filed. Considering the facts that the EC has invited Prof. Nazim Husain Jafri to be appointed as a Professor under Statute 25(8) of JMI Act. It was not expedient and proper for the then Offg. Vice-Chancellor to have taken a stand against the decision of the EC. Therefore, the House approves the stand taken by the University to protect the Statute and the Act of JMI. However, it is resolved that administration of the University shall take appropriate steps in accordance with law for such steps taken before the Court.

**REPORTING OF LEGAL EXPENSES INCURRED BY THE UNIVERSITY IN THE CASE OF MD. SHAMI AHMAD ANSARI & ANR. V/S JAMIA MILLIA ISLAMIA & OTHERS**

**DECISION**

The EC has deliberated upon the matter at great length. One of the Members requested the Chairman to request the Secretary of the EC to produce the original file in respect of the expenditure incurred by the University to defend its stand in the case of 'Md. Shami Ahmad Ansari & Anr. V/s JMI & Ors.' and 'Anwar Khan V/s JMI' before Hon'ble High Court of Delhi. Perusal of the record, it has been shown that the University had engaged a Senior Counsel (Non-Additional Solicitor General of India) to argue the matter on behalf of the University before the Hon'ble High Court of Delhi. It has also taken a note of the fact that the Standing Counsel was directed not to appear in the matter, as two other panel counsels were engaged to brief the Senior

Counsel. In these circumstances, during the various dates of hearing, the University administration had approved and had incurred an expenditure of approx. Rupees 47 lakhs to pay the fees to Counsels.

Perusal of the material on record show that the approval of memo of fees were not as per the procedure, ordinarily, followed by the University and also no reason has been found on record to disagree with the recommendations of the AR (Legal) for not appointing / hiring / engaging an Additional Solicitor General of India which the University generally engages.

During the perusal of record, it was discovered by one of the members that there has been an interpolation and tampering in the note sheet dated 23.11.2023 in the noting of the then AR (Legal). The tampering and interpolation is apparent on record. The House has deliberated and taken serious note that wrongful loss of rupees 47 lakh to the University by circumventing procedure and also no justification is sent from the record for such public money having been misused.

In view of the above circumstances and the seriousness of the matter, the House has unanimously resolved to set up a High Level Inquiry to ascertain the fact of who is liable for such wrongful loss as well as to ascertain and to inquire strictly in respect of tampering and interpolation of public record. It has also been resolved that the records pertaining to the case as well as approvals of the note sheets are directed to be seized and be placed in the sole custody of the Secretary of the EC forthwith and the records shall only be handed over to the Inquiry Committee. The record should not be made available to the public at large and such information should not be made available under RTI Act till the completion of the inquiry.

The House approves the following composition of the Inquiry Committee:-

The inquiry be completed within a period of four (04) weeks in a sealed cover. The Finance Officer and all other Sections is also directed to hand over forthwith all records of such expenditures to the Secretary of the EC.


