



## MEMORANDUM OF UNDERSTANDING (MOU) between Al-Mustafa International University, Qom, Iran and Jamia Millia Islamia, New Delhi, India

Dr. Ali Reza Arafi the Vice-Chancellor of the Al-Mustafa International University, Qom, Iran and Prof. Talat Ahmad, Vice-Chancellor of Jamia Millia Islamia, New Delhi, India agreed together, based on the existing cordial relation to promote and broaden their mutual collaboration in the field of education and culture. Both will take necessary steps in this regard.

WHEREAS both the sides agreed to promote and broaden the activities of both the institutions with the vision that it will be a new phase in rejuvenating the Indo-Iran relations in order to broaden the researches and mutual exchanges of scholars.

## The point for mutual consent will be based on the following issues:

- 1. Researches in the field of humanities, culture, history, Persian languages & literature, management, Mass Communication, Islamic Studies etc.
- 2. Provision for scholarship at Master & Doctorate level for the eminent scholars of India and Iran.
- 3. Establishment of chairs of eminent scholars in Al-Mustafa International University, Iran and Jamia Millia Islamia, New Delhi.
- 4. Exchange of scholars.
- 5. International seminars, conferences and symposium.

Both the sides will cooperate and collaborate in materialization of the MoU and other relevant activities deemed mutually appropriate.





Mr. Mohammad Reza Saleh, the representative of Al-Mustafa International University in New Delhi will coordinate and supervise the implementation of MoU between Al-Mustafa International University, Iran and Jamia Millia Islamia, New Delhi.

## MISCELLANEOUS

- (a) The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- (b) The parties to this Memorandum may, by mutual consent, add modify, amend, delete review or revise any term(s) and condition(s) of this Agreement.
- (c) The intent and implementation of this Memorandum is **SUBJECT** to the policies of the respective States (in case of international agreements) and the laws of the land.
- (d) This Memorandum of Understanding shall remain in force for a period of \_\_\_\_\_\_\_ years from the date of its signature and seal, and may be terminated by either side by giving a six months Notice to that effect in writing. However, notwithstanding the Notice of the intent to terminate the Memorandum, all rights, obligations and corresponding duties flowing and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- (e) The parties to this Memorandum of Understanding undertake to treat as "confidential and privileged" information of the other institution which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
