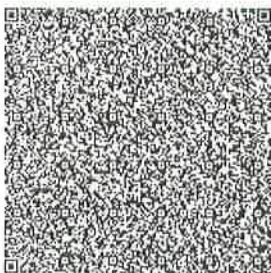

MEMORANDUM OF UNDERSTANDING

Between

JAMIA MILLIA ISLAMIA
(A Central University)

And

PAWAN HANS LIMITED
(A Government of India Enterprises)

This Memorandum of Understanding (MOU) is made on this 27 day of July 2017 at New Delhi between **JAMIA MILLIA ISLAMIA** (a Central University [hereafter called **JAMIA MILLIA ISLAMIA**], located at Maulana Mohamed Ali Jauhar Marg, Jamia Nagar, New Delhi-110025 (which expression shall unless it be repugnant to the context or meaning thereof be deemed to mean and include its administrators, successors and assigns) of the One Part;

AND

PAWAN HANS LIMITED (A Government of India Enterprises) under the administrative control of Ministry of Civil Aviation, GOI [herein after called **PAWAN HANS LIMITED**] was incorporated as Company under the provision of The Companies Act 1956, having its Corporate office at C-14, Sector-1, Noida, UP-201301 (which expression shall unless it be repugnant to the context or meaning thereof be deemed to mean and include its administrators, successors and assigns) of the Other Part.

WHEREAS:

- (a) The PAWAN HANS LIMITED is engaged in maintenance and operation of helicopters in aviation sector and conducting courses in the field of Aircraft Maintenance Engineering as approved by DGCA, GOI through its academic branch Pawan Hans Helicopter Training Institute (PHTI) so as to make the student eligible to acquire License from Director General of Civil Aviation. PAWAN HANS LIMITED has tools & equipments required for aircraft maintenance, workshops, library, manpower required for training students. It will be conducting B.Sc. (Aeronautics), a three year full time course in Aircraft Maintenance Engineering under the regular Self Financed Scheme (SFS). This course shall also be approved as three years course in Aircraft Maintenance Engineering from Director General of Civil Aviation (DGCA) Govt. of India.
- (b) JAMIA MILLIA ISLAMIA, an Institution established in 1920 during the Khilafat and Non-cooperation Movement, became a Central University by an Act of Parliament in 1988. In English language, 'JAMIA' means 'University' and 'MILLIA' means 'National'.
Today, JAMIA MILLIA ISLAMIA is an "A" grade Central University accredited by NAAC and is an ensemble of a multi layered educational system which covers all aspects of schooling, under-graduate and post-graduate, and M.Phil. /Ph.D. education. It is also collaborating with various Institutions and Industries to train students to meet the demand of diverse industries.
- (c) The parties hereto have decided to collaborate in the field of training for the service sector in the aviation industry by initially providing a course for B.Sc. (Aeronautics). The parties also agree to explore the possibility of launching B.Sc (Aviation) and a final determination would be made after looking into all aspects of the matter which will manifest as an addendum to this MoU.

- (d) The parties hereto have decided to set forth in writing the terms and conditions of the MOU arrived at between themselves.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. JAMIA MILLIA ISLAMIA (a Central University) and PAWAN HANS LIMITED (a Govt. of India Enterprises) will technically collaborate to conduct aforesaid B.Sc. (Aeronautics) course having total course duration of three academic years each (Approx. Class room study 2205 hours + practical and field work 1200 hours. Total: 3405 hours).
PAWAN HANS LIMITED will offer B.Sc. (Aeronautics) course at the campuses of JAMIA MILLIA ISLAMIA and PAWAN HANS LIMITED. It will be the responsibility of JAMIA MILLIA ISLAMIA in association with PAWAN HANS LIMITED to maintain teaching standards and content. PAWAN HANS LIMITED would be designated as an outreach centre of JAMIA MILLIA ISLAMIA, and the course would be conducted and delivered by PAWAN HANS LIMITED, under the aegis of JAMIA MILLIA ISLAMIA. All enrollments and payment of fees would be done at JAMIA MILLIA ISLAMIA/PAWAN HANS LIMITED mutually and the students would be required to purchase the Admission Forms either through JAMIA MILLIA ISLAMIA or through PAWAN HANS LIMITED.
2. The course will be open to male and female candidates. Reservation rules for student admission will be as per norms applicable in JAMIA MILLIA ISLAMIA.
3. JAMIA MILLIA ISLAMIA and PAWAN HANS LIMITED will jointly prepare the training curriculum and will make arrangements for examination venue.

4. JAMIA MILLIA ISLAMIA will provide pedagogical inputs and administrative coordination for which JAMIA MILLIA ISLAMIA shall appoint Coordinators. JAMIA MILLIA ISLAMIA shall also provide faculty support and faculty training at a reasonable price and will offer appropriate guidance for placement. Further the following shall be developed and provided with joint consultation by both the parties:
- a) Providing the syllabus
 - b) Deciding the examination Time-Table
 - c) Setting of question papers for the Degree/Certificate
 - d) Declaration of results and awarding of Degree/Course Completion Certificate.
 - e) JAMIA MILLIA ISLAMIA shall provide classrooms for theoretical instructions whereas practicals will be conducted at PAWAN HANS LIMITED have approved facility.
 - f) JAMIA MILLIA ISLAMIA shall provide various laboratories/ workshop facilities in the university campus for demonstration and allied purposes as part of the basic curriculum/syllabus.
 - g) JAMIA MILLIA ISLAMIA shall allow/facilitate students pursuing B.Sc. (Aeronautics) to participate in University sports/ cultural/ academic activity programs.
 - h) JAMIA MILLIA ISLAMIA shall allow/facilitate all such students to participate in University campus interview and placement programs.
5. The above said course jointly offered by JAMIA MILLIA ISLAMIA and PAWAN HANS LIMITED, shall be conducted at **Delhi** as per the prescribed syllabus and rules and regulations jointly determined by JAMIA MILLIA ISLAMIA and PAWAN HANS LIMITED. This course would have suitable description in JMI Prospectus and Admission Brochure of PAWAN HANS LIMITED.
6. There shall be registration for all the admissions.

7. The admission will be jointly made as per JAMIA MILLIA ISLAMIA/PAWAN HANS LIMITED admission notification.
8. The theory classes and the practical work on subjects will be conducted by the qualified teaching staff, instructors and the trainers of JAMIA MILLIA ISLAMIA and PAWAN HANS LIMITED conforming to accepted standards. The right to the appointment of staff (regular and visiting) vests with the Administration of JAMIA MILLIA ISLAMIA and PAWAN HANS LIMITED.
9. The fee structure of the course proposed will be jointly determined by both the institutions/bodies through their representatives and the fee sharing arrangement would be put in place keeping in mind the expenses involved in running the proposed academic programme. The fee-sharing arrangement will be an addendum to this MoU.
10. Degree in B.Sc (Aeronautics) will be provided to all successful students by JAMIA MILLIA ISLAMIA. PAWAN HANS LIMITED will provide its own course completion certificate so as to enable students to acquire DGCA license.
11. PAWAN HANS LIMITED will have proprietary rights over the curriculum.
12. The activities and progress of the work will be reviewed periodically on a monthly basis and as and when required by the assigned Coordinators of JAMIA MILLIA ISLAMIA and Chief Instructor/Dy. Chief Instructor of PAWAN HANS LIMITED for suitable actions.
13. The details for the efficacious implementations of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the Institutions.
14. The parties to this Memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition (s) of this

Agreement. Provided that any such modification, amendment, deletion, review or revision shall be in writing.

15. This Memorandum of Understanding shall remain in Force for period of three (3) years from the date of its signature and seal, and may be terminated by either side by giving a six months Notice to that effect in writing. However, notwithstanding the Notice of the intent to terminate the Memorandum, all rights, obligations and corresponding duties flowing and subsisting therein, which had been formalized while the MOU was in operation, shall be respected and mandated till the finalization and accomplishment thereof.
16. This Memorandum of Understanding will not generate legally binding obligations for the Parties. Nothing mentioned in this Memorandum of Understanding shall deem to constitute partnership between the signing parties appointing one party as an agent of the other.
17. The parties to this memorandum of Understanding undertake to treat as "**confidential and privileged**" Information of the other institution which is so classified in advance. The Terms of Confidentiality and mode of disclosure shall be as per mutually acceptable terms.
18. This Memorandum of Understanding shall require the Ratification of the competent academic/ executive body of both the Institution.
19. In the event of any dispute arising between the parties hereto in connection with the present MOU, it shall be the endeavor of both the parties to first make an attempt to resolve the disputes amicably by mutual discussion and deliberations, failing which the disputes shall be referred to Arbitration. The Arbitration shall be conducted as per the provisions of Arbitration and Conciliations Act, 1996. The Arbitral Tribunal shall consist of a Sole Arbitrator, to be appointed mutually by both the parties. The venue of Arbitration shall be Delhi. The language of

Arbitration shall be English. The award of the Arbitral Tribunal shall be final and binding on the parties.

20. In the event of any proceedings being adopted by either of the parties hereto in regard to the terms and conditions of this MOU and the implementation thereof the Courts in Delhi alone shall have exclusive jurisdiction.
21. There will be a Joint Committee of two officials i.e. Registrar of JAMIA MILLIA ISLAMIA and Executive Director (HR&Admn.) of PAWAN HANS LIMITED to oversee and monitor the successful implementation and effective governance of MOU.


