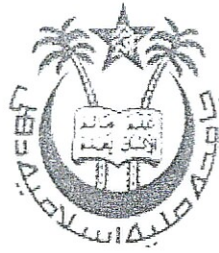


**MEMORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**JAMIA MILLIA ISLAMIA, NEW DELHI, INDIA**  
**AND**  
**Hebron UNIVERSITY, Hebron, PALESTINE**

JAMIA MILLIA ISLAMIA, a Central University under an enactment of the Parliament of India (i.e. the Jamia Millia Islamia Act, 1988) and is a body corporate with a perpetual succession and a common seal and Hebron UNIVERSITY establish hereby a formal understanding of cooperation to following terms and deeds in pursuance of a common intent to promote and develop the study of Cultural, Educational and Scientific studies and Islamic studies.

**1. FIELD OF COOPERATION:**

- (a) Both institutions shall evolve a mutually acceptable schedule to develop programme, hold seminars and exchange visits.
- (b) The said academic interaction and intellectual assimilation may include-
  - (i) Faculty/Staff development and exchange;
  - (ii) Exchange of Students;
  - (iii) Seminars, research, conferences and workshops;
  - (iv) Collaborations in the sharing of academic data, scientific information, intellectual property, articles and publications;



- (v) Advice surgeries, placements and executive training;
- (vi) Other forms of cooperation which the two institutions may jointly arrange.
- (vii) The cooperation will be focused on the following fields of study initially:  
Interdisciplinary Masters and Ph.D in International Relations & Area Studies, Psychology, and Arabic Language and Literature.

## **2. EXCHANGE OF STUDENTS/FACULTY MEMBERS:**

- (a) Reciprocal arrangements based and mutually acceptable terms shall be accomplished to give and impetus to collaborative research and joint projects. Teachers, researchers, guides and student of both institutions shall be encouraged to work in tandem in the laboratories, workshops, faculties and departments of both institutions.
- (b) Issues relating to travel, boarding, lodging, miscellaneous expenses shall vary according to the rules, regulations and policies of both institutions.

## **3. MISCELLANEOUS:**

- (a) The details for the efficacious implementations of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both institutions.
- (b) The parties to this Memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition (s) of this MoU.
- (c) The Financial arrangements involved in the implementation of this Agreement shall be settled through consultation between the two institutions in respect of each program of cooperation.



(d) The intent and implementation of this Memorandum is SUBJECT to the policies of the respective States (in case of international agreements) and the laws of the land.

(e) This Memorandum of Understanding shall remain in force for period of (FOUR) years from the date of its signature and seal, and may be terminated by either side by giving a six months Notice to that effect in writing, However, notwithstanding the Notice of the intent to terminate the Memorandum, all rights, obligations and corresponding duties flowing and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.

(f) The parties to this memorandum of Understanding undertake to treat as **“confidential and privileged”** information of the other institution which is so classified in advance. The terms of Confidentiality and mode of disclosure shall be as per mutually acceptable terms.

(g) This Memorandum of Understanding shall require the ratification of the competent academic/ executive body of both institutions.
