Additionally, he serves as the Coordinator for Capacity Building on Specific Learning Disabilities (CBSLDs) under the Department of Higher Education, Ministry of Education (2024). Dr. Khan is dedicated to influencing and shaping policies that safeguard the rights of individuals with disabilities, ensuring they have access to quality education and necessary support services.
